8.2. Exposure controls

As the use of adequate technical equipment must always take priority over personal protective equipment, make sure that the workplace is well aired through effective local aspiration.

Provide appointed staff with adequate training on how to use chemical products.

Product's classification is based on the calculation methods set out in Annex I of the CLP Regulation, unless otherwise indicated in sections 11 and 12.

The data for evaluation of chemical-physical properties are reported in section 9.
